- 1) Assigned object
ALLMATIC-Jakob Spannsysteme GmbH leaves articles, which are checked on page 1, for temporary testing to the company

- 2) Assignment period
The loan period is two weeks from the date of shipment.
- 3) Contract penalty
Should the temporarily assigned objects not be returned to ALLMATIC-Jakob on time, we will be charging a fee of 250 € per sample case set (plus VAT) per started week. As a result, a lease will not be established. The legal claim of title stands.
- 4) Assignment costs
 - Delivery to the customer is CPT carriage paid. Return shipping will be paid by the customer. This includes packing, duty costs and any other costs that may incur.
 - If the pressure measuring socket is damaged by improper use, the repair costs will be charged to the customer's account. The same will apply for missing goods.
 - Wear parts will not be invoiced to the customer.
- 5) Property
The goods remain the property of ALLMATIC-Jakob Spannsysteme GmbH, during the term of this agreement.

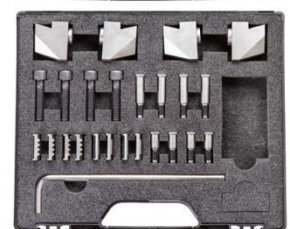
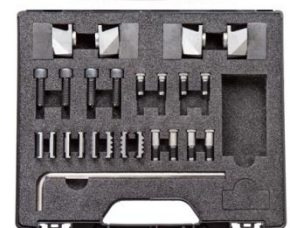
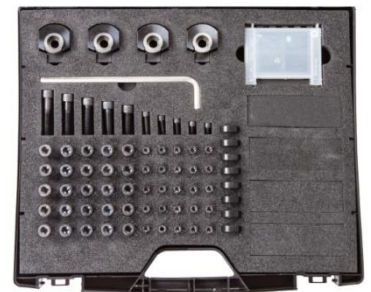
